Mary Lou Addor, Associate Director, NCSU's Natural Resources Leadership Institute

Through education, training, research, and facilitation, Mary Lou assists organizations and various sectors of government with environmental decision-making in North Carolina. Since 1997 she has served as the Associate Director of the Natural Resources Leadership Institute, a multifaceted instructional and community service program housed at NC State University. Her areas of expertise include program and leadership development, public participation, and interorganizational development. Mary Lou leads the Institute's Leadership Development Program, an 18-month training and development program for educators, environmentalists, local governments, regulators, business and industry representatives, community groups, and interested citizens. She has worked extensively with these same organizations on various public policy disputes. A few project examples include: the NC Interagency Leadership Plan for the Environment, Mobility, & Economic Development; the Nantahala and Tuckaseegee FERC Relicensing Process; and the Chattooga Wild & Scenic River Situation Assessment and Public Forums. She has published articles on natural resources leadership development and conflict resolution.

Al Delia, President, NC's Eastern Region

Al is the President and CEO of North Carolina's Eastern Region Development Commission. In this role, he is responsible for the management and strategic visioning of a 13-county region with over \$26 million in assets and a \$2.9 million annual operating budget. He develops plans for business recruitment, retention, expansion and creation within identified target industry clusters and is implementing a first-in-the-nation plan to identify and recruit foreign direct investment within target areas. He works with regional, state-wide, and national leaders to increase resources available for economic development and fosters new partnerships with the private sector, educational institutions of all levels, government agencies, and not-for-profit organizations. Al is a leader of economic development efforts for Eastern North Carolina, including the design, start-up, turn-around, growth and operation of a variety of business, political, governmental, and educational organizations. He has over 20 years of experience working effectively with Boards and Advisory Groups and collaborating with diverse sets of workforce, economic development, and educational organizations. Prior to his work at the Eastern Region Development Commission, Al spent twenty years working in economic development for North Carolina's University System between East Carolina University (ECU) and the University of North Carolina at Chapel Hill. Al holds a Bachelor of Arts in Political Science from Drew University and several certificates in fundraising, grant-writing, and event and product sponsorship.

Renee Cahoon, Mayor, Town of Nags Head

Renee is currently serving her third term as Mayor. She was elected Commissioner of Nags Head in 1991 in the municipal election and voted Mayor by the full Board of Commissioners a month later. Renee has been Mayor of Nags Head for ten years, interrupted only by her service as a member of Dare County Commissioners from 2000-2004. Some of her important goals are: protecting the Town's fragile environment, acquiring land for open space and responsible fiscal management.

Barbara Doll, Water Quality Specialist, NC Sea Grant

Barbara is the) water quality specialist for N.C. Sea Grant, a federal/state program that promotes the wise use of coastal resources. Based at NC State University, Barbara provides information to the public and local governments about water quality status, research and regulations. Much of Barbara's current work is focused on repairing degraded stream systems and reducing the impacts of stormwater runoff and nonpoint source pollution. With grant funding from both state and federal agencies, she has implemented several stream restoration projects, including a small tributary of Hewlett's Creek on Pine Valley Golf Course in Wilmington and a tributary of Yates Millpond in Raleigh. She is currently spearheading the \$7 million overhaul of a highly degraded urban stream corridor located on the NC State University campus. Barbara has bachelors and masters degrees in civil engineering from N.C. State University. Before joining Sea Grant in 1992, she specialized in water resources and surface water quality in consulting work and graduate school.

Jason Doll, Associate/Senior Scientist, Stantec

Jason leads the Water Resources Planning Group for Stantec Consulting in Raleigh. Prior to joining Stantac, he worked for six years as a water quality modeler with the NC Division of Water Quality. Jason has 15 years of experience leading watershed planning and modeling studies for the assessment and management of point and non-point sources of pollution. Jason came from one of the most remote areas of the northeastern North Carolina coast to attend NC State University where he graduated with a BS in Fisheries and Wildlife Science in 1987. He is a Certified Professional in Storm Water Quality.

Kim Douglass, Conservation Planner, NC Department of Environment and Natural Resources

Kim is the Conservation Planner in NC DENR's Natural Heritage Progam. She and her colleagues are developing a strategic conservation planning tool that identifies, evaluates and prioritizes significant natural resources on a statewide scale using a green infrastructure approach. Kim spent the last 12 years working in the planning field for NC's local, county, and state governments, as well as for a non-profit. She served as the Open Space Planner for Wake County, the Stewardship Director for The Triangle Land Conservancy, Trail and Park Planner for the City of Durham, and as a Trails Specialist for the State Trails Program. Bill Holman, Director of State Policy, Duke University Nicholas Institute of Environmental Policy Solutions

Bill has been at Duke's Nicholas Institute since December 2006. He was Executive Director of the Clean Water Management Trust Fund for six years prior to that. Bill served as Secretary of the N.C. Department of Environment and National Resources and Assistant Secretary for Environmental Protection from 1998 to 2000. Previously he was a lobbyist to the N.C. General Assembly for numerous environmental nonprofits and advocacy organizations for 18 years. Bill is credited with helping to pass the Clean Water Responsibility Act of 1997, the Brownfields Cleanup Act of 1997, the Clean Water Management Trust Fund Act of 1996, the Watershed Protection Act of 1989 and numerous other environmental bills. In 1999, he was named Conservationist of the Year by the North Carolina Wildlife Federation. Governor Hunt awarded Bill one of the state's highest civilian honors, the Order of the Long Leaf Pine, in 2000.

Jeff Hughes, Director, Environmental Finance Center

Jeff currently serves as the Director of the Environmental Finance Center (EFC). EFC is housed within the School of Government (SOG) at the University of North Carolina and is one of a network of nine applied environmental research and outreach centers across the country. Jeff's professional experience includes direct local government environmental management, research, consulting, financial analysis, university teaching, and professional continuing education. He is the author of numerous reports, guides, and articles on environmental finance and environmental policy analysis subjects. His current teaching load includes over a dozen professional education courses and workshops serving hundreds of utility directors, finance directors, local government managers, and elected officials each year. Hughes works with a range of state and national organizations that focus on utility and environmental issues including holding a seat on the NC water operator's certification board and serving as an expert witness to the EPA Environmental Finance Advisory Board.
